### **ERRATUM NOTIFICATION**

Read :1. Notification No. AdD1/16269/SSUS/2021 dated 24.11.2021.

2. Judgement of the Hon'ble High Court dated 03.11.2022 in WA No 1407/2022.

Vide Notification read (1) above applications were invited for appointment to the post of Assistant Professors in various departments in the University. The University follows Clauses (a), (b) & (c) of rule 14 and the provisions contained in rule 15, 16 and 17 of KS & SSR, 1958, as amended from time to time, for making appointment. All vacancies available at the time of notification in all the departments of University are considered as a single unit for the purpose of reservation/rotation.

As per rule 15 (a) of KS&SSR 1958, if a suitable candidate is not available for selection from any particular community or group of communities specified in the Annexure, such vacancy shall be kept unfilled, notified separately for that community or group of communities for that selection year and shall be filled by direct recruitment exclusively from among that community or group of communities. If after re-notification, repeatedly for not less than two times, if no suitable candidate is available for selection from the respective community or group of communities, the selection shall be made from the available Other Backward Classes candidates. In the absence of Other Backward Classes candidates, the selection shall be made from the Scheduled Caste candidates and in their absence, the selection shall be made from available Scheduled Tribe candidates. As per rule 15 (b), if a suitable candidate is not available for selection from the group of communities classified

as “Scheduled Caste” in the turn allotted from such group in the Annexure, the said group shall be passed over and the post shall be filled up by a suitable candidate from the group of communities classified “Scheduled Tribes” and vice versa.

Vide Judgment read as second above, the Hon’ble Highcourt directed the University to issue an erratum before proceeding with the notification read as 1<sup>st</sup> above indicating clearly the particulars of the candidate who are entitled to apply for selection against the vacancy earmarked, if no candidate is available from the Ezhava community even after successive re-notifications. In pursuance of this judgement, this erratum notification is issued.

**Applications are therefore, invited from those candidates who belong to other eligible communities and are interested to be considered for appointment to such vacancies reserved for communities/ categories as given in the table below, if no suitable candidate are available for the selection based on the original notification read (1) above and even after renotification repeatedly for not less than two times in accordance with Rule 15 (a) and (b) of the KS&SSR, 1958.**

Candidate belonging to the category mentioned in column 3 are not eligible to apply afresh against the vacancies in the respective rows in column (2) of the table given below as per this erratum notification. Such applications received, if any, shall be summarily rejected without any refund of application fees already remitted.

\*Except for vacancies mentioned against serial no 3, 9 & 11, candidates belonging to SC may be considered in the absence of suitable candidates for appointment from Other Backward Classes even after two successive re-notification and in the absence of suitable candidates belonging to SC, candidates belonging to ST may be considered.

### **Instructions**

- a) The Qualifications for each post should be as per the UGC Regulations 2018, as amended from time to time.
- b) All eligible Other Backward Classes, SC, ST candidates can apply.
- c) The relaxation in age will be admissible for the candidates belonging SC/ST/OBC/PH as per the existing rules in this regard.
- d) Caste certificate in the case of SC/ST candidates, Non Creamy Layer Certificates in the case of eligible communities and certificates issued by competent Authority in the case of PH candidates have to be produced.
- e) Applications to the above posts shall be submitted online in the prescribed format available in the University website [www.ssus.ac.in](http://www.ssus.ac.in)
- f) Last date of submission of online applications 21.01.2026

- g) The hard copies (8 sets) of the filled up online applications along with all documents including the PBAS sheets should reach **The Registrar, Sree Sankaracharya University of Sanskrit, Kalady-683574** before 4.00 p m on 28.01.2026.
- h) **Registration Fee: Rs 2000/-** , for SC/ST /PH Candidates **Rs 500/-**
- i) Mode of Remittance -By Online Remittance.
- j) Registration fee is non-refundable under any circumstances.
- k) Candidates who have already applied vide notification read (1) need not apply.
- l) The late and defective applications will be summarily rejected.

**Note :** *The candidates who apply in pursuance to this erratum notification will be considered for selection only if no suitable candidates are found eligible for appointment in the respective categories who applied as per the notification read as 1<sup>st</sup> above and after renotification repeatedly for not less than two times. The University reserves the right to issue further re-notification of more than two times in search of the suitable candidates from the respective communities, if deemed necessary.*
